Platinum Wine Club Membership Terms & Conditions

1. ~~There is a one time \$50.00 membership fee to join.~~ *For a limited time we are offering Inaugural Platinum Club Memberships with no fee to join!*
2. Platinum Wine Club Members receive one Club Case shipment two times per year. Your Club Case (12 bottles) includes 9 reds and 3 whites.
3. Members receive a 25% discount on all wine purchases, including your Club Case shipments. Your Platinum Club Discount cannot be combined with other discounts.
4. A \$50.00 deposit is required. \$25 of your deposit will be applied as a credit to your 1st Club Case shipment and the remaining \$25 of your deposit will be applied to your 2nd club case. If your membership is cancelled prior these shipments, the deposit is non-refundable.
5. Credit cards secured on file are charged within 2 weeks to scheduled shipment of your Club Case. All Club Cases will be shipped, unless prior arrangements are made. Club Case shipment occurs two times per year, once in March and once in October. An adult 21 years of age or older must sign to receive your shipment.
6. You may cancel your membership after receiving 2 Club Case shipments. There is no cancellation fee. In order to not receive the next Club Case shipment, submit cancellation **30 days prior to the next scheduled Club Case shipment dates.** All requests for membership cancellation must be submitted in writing to us at:
